## Scheduling issues....



As I write this we've just come off the weekend of another attempt to schedule overtime both on and off the OTDL. Not surprisingly, it didn't work so well. I guess the one part I really don't understand is that the message to bump up the overtime to get the delayed flats prepped came out on Thursday afternoon but nothing happened until Friday night. 
My next subject is something I've brought up to some members and many Supervisors over the years but it continues to be a problem. The holiday sign-up sheet is for a 3-day period only. If your non-scheduled day(s) are not a part of that 3-day period, please do not sign the list to volunteer to work your non-scheduled day. An example of what I'm getting at...let's use a Monday holiday. The 3-day holiday period is Saturday, Sunday & Monday. Unless at least one of your non-scheduled days falls on those 3 days, do not sign the volunteer list for non-scheduled day. For all days outside that 3-day period, the normal OTDL rotation must be used. Signing your name to that list only complicates things and causes confusion for some. I'll use the 4<sup>th</sup> of July this year for another example. It falls on Wednesday and let's say you have Saturday/Sunday off. The 3-day holiday period is Monday, Tuesday & Wednesday. You certainly may sign up to work your holiday (Wednesday) but to sign up for your days off (Saturday & Sunday) would not be legitimate.

Hopefully your Supervisor is using the OTDL for those days. Now let's switch your days off to Sunday/Monday. Sunday should fall into the regular OTDL rotation while Monday will be assigned per the holiday pecking order so go ahead and sign up for Monday if you want. And a couple of side requests... please don't write in other people's

names, please don't write in "No, No, No" and for sure quit writing in "Hell No". If there's anything I wasn't clear on and you have questions, please, feel free to ask & I'll try to explain it better. I won't make this explanation worse by going into detail but sometime when we hit a Sunday holiday, be sure to check on it because it can be a little weird.

Members, remember to get your COPA raffle tickets for the Hawkeye stuff being drawn for at this month's meeting. Also, check the board for a year-long raffle we have going. Those of you who have COPA donations automatically withdrawn have been entered in the year-long raffle but you'll have to buy separate tickets for the short-term monthly raffles.

### New Business:



### POSTAL NEWS

### Plan to shutdown 3 postal centers halted.

Acting on concerns raised by labor and community activists, a congressman has stepped in to put a temporary hold on plans to close three Bronx mail processing facilities.

The Inspector General of the U.S. Postal Service will review the controversial proposal following the intervention of Rep. Jose Serrano (D-NY) at the behest of postal union members and community groups.

Shortly after raising the issue with Postmaster General John Potter, Serrano, chairman of a powerful subcommittee with control over the USPS budget, received a letter from Potter backpedaling on the closure plan.

"I understand and take very seriously concerns you voiced regarding this potential consolidation of the Bronx mail processing operations into Morgan Station in Manhattan," Potter wrote. "I have requested the Office of the Inspector General (OIG) to perform a thorough review of this proposed consolidation."

"This will at least give a chance to examine the actual effects it would have," said Serrano. "Short of stopping it from happening outright, this was a good result."

### Congressman wants answers.

In a recent letter to a U.S Postal Service (USPS) official, Congressman Bart Stupak, D-MI, has asked for an update on a study some fear threatens to close the mail processing facility in Gaylord.

As of March 9th, Stupak had not received a response to his Feb. 7 letter addressed to Tom Day, senior vice president of government relations for the USPS, according to his press secretary Alex Haurek.

The controversy dates back to an Area Mail Processing (AMP) study at the Gaylord facility, which began in December 2005. The study analyzes the feasibility of moving the processing and distribution operations, which generally employ about 80 of the 120 postal positions in Gaylord, to Traverse City.

The AMP survey has drawn criticism from American Postal Workers Union (APWU) officials in the past, spilling into their participation of local APWU members in a nationwide day of picketing last October

Critics of USPS handling of the matter believe the AMP has long exceeded the 180-day time frame to complete such a study, referenced in the USPS Handbook PO-408.

In his letter, Congressman Stupak specifically highlighted reported personnel decisions coupled with installation of modern processing equipment at Traverse City and denial of equivalent equipment for Gaylord as troublesome. Stupak questioned the appearance of unfair treatment for the Gaylord plant, which could skew the AMP results in favor of consolidation with the Traverse City facility.


